Communication between School and Home

All families have been invited to use SeeSaw as the main method of communication between home and school. Students and families each have their own access to the platform. SeeSaw allows for sharing using both private and/or group messages.

Families will also continue to access whole school communication channels including:

- Facebook
- Twitter
- Parent and Student Portal
- Email

Remote Learning Plans

For most of Term 2, each student will be provided with a weekly remote learning plan that will be uploaded to SeeSaw by 3pm Friday for the following week. Remote learning plans will outline learning activities for completion throughout the week. Students and families will have flexibility to complete tasks at times that work with their daily routines.

Where possible, remote learning plans will include a mix of digital and non-digital activities. Students are encouraged to submit digital activities through the platform listed on the plan. Non-digital activities may be submitted to the teacher by one of the following methods:

- Through scanning or photographing of completed work that can be uploaded to SeeSaw
- Via email directly to teacher
- By collating printed work to be mailed to school at key points throughout the term

Frequently Asked Questions (FAQs)

When does school resume in Term 2?

NSW Schools have been allocated two staff development days in Term 2 to better prepare for emergency planning. Remote learning will resume for all students on **WEDNESDAY 29 APRIL 2020.**

When should my child return to school?

NSW Schools remain open to children of parents who are essential workers. As of Week 3 of Term 2, if your child is <u>fit and healthy</u> they are encouraged to attend school on the following days:

If your child is in an at-risk group for COVID-19 or the family has been directed to self-isolate by NSW Health then they should not attend school.

Will assisted transport still be available?

The Assisted School Travel Program (ASTP) continues to operate under NSW Health social distancing and hygiene guidelines. ASTP providers are required to ensure their vehicles are safe and all support offices have been advised to follow good hygiene processes and to continue to monitor advice from NSW Health.

What if my child has an underlying health condition?

Parents and carers of children and young people with complex medical needs are encouraged to seek medical advice from their health practitioner. The school will work together with parents and carers and the student's health care team to ensure they have an appropriate plan in place to support the student to continue their learning at home if needed.

Children accessing remote learning at home will not be considered 'absent' from school and their attendance record will not be affected.

What if my family lives with an elderly or at-risk person in the home?

Families who live with elderly or at-risk people are encouraged to seek medical advice from their health practitioner. The school will work together with parents and carers to ensure they have an appropriate plan in place to support the student to continue their learning at home if needed.

Children accessing remote learning at home will not be considered 'absent' from school and their attendance record will not be affected.

Will my child have their regular classroom teacher during the phased return to school?

Not necessarily. On the set days of the phased return to school, we will try to ensure your child is supported by an experienced disability support teacher, however due to some staff being required to work remotely, your child may need to work with a different teacher, with different students and in a different room. We understand this will be a significant disruption of routine for your child and the school will work hard to support them as they adjust.

During other days outside of the phased return to school, your child will be provided with minimal supervision by staff available on the day.

What work will my child be doing at school?

All students will continue to work from their remote learning plans both at home and school. School lessons provide an opportunity for teachers to support students to understand the activities, explicitly teach ICT skills and demonstrate task completion.
